The meeting of Faculty Council 05/19/2023 was called to order by Chairperson Mike Leneaugh at 9:14am, at the Science Building.

Agenda items:

- 1. Opening prayer: Opening Prayer was led by Dr. Jim Green at 9:15 am.
- 2. Review the meeting notes from the last meeting for committee approval. Voting item #1.

 No discussion or revision requested. Motion to approve by Jerry Smith; seconded by Ronnie Jackman.

- 3. Any announcements /information relevant to the Faculty Council that members wish to share. No announcements, or discussion of old/new information.
- 4. Brief check-in for any last-minute questions about next week's Summer Registration process.
 - a. Reminder of Summer Registration week, and calendar revision: Friday workday has been changed to Tuesday, due to Elder's Day Tribal Holiday on Friday, and Memorial Day on Monday.
 - b. Registration will not be for New Students or Dual Credit, only continuing students, 100 expected.
- 5. Presentation by Jim Green of creation of Institute for indigenous Teaching, and the plan to use the log building on the old campus as a Faculty Center.
 - a. Presentation noted that the riginal Lakota Studies program was not accredited by HLC; it was changed to Lakota Institute for Teaching and Learning.
 - b. The goal of the Institute is to increase or emphasize the Tribal College aspect of SGU, and how to be more relevantly "indigenous" (via WINHEC) than other non-tribal schools that have native faculty/administration, native students, and native study courses.
 - c. The function of the Faculty Center was for faculty research and faculty sharing of how to increase indigenous practice on campus, such as language incorporation in speaking and text.
 - d. Discussion proposed of creation of an Elder/Mentor program for both faculty education and classroom mentoring to student in the course.
 - e. Discussion suggested seeking of funding to support an Elder/Mentor program.
 - f. Faculty members discussed the "Pro's" of individualized self-paced learning, and group learning, noting that children learn by doing and being mentored, at an individual pace—mirroring the historical indigenous culture learning/doing method.
 - g. Faculty discussed the "con's" of how individualized learning conflicted with syllabi Learning Outcomes:
 - ---What happens when students do not complete all PLO's in a course? Passing grade, with expectation to continue retaking same level course until all PLO's are achieved? Receive an incomplete until all PLO's are achieved?
 - ---It was noted that continuous self-paced learning conflicts with funding/grant expectations of X time period to complete a degree, or funding for X number of courses.
 - h. Dr. Green concluded that SGU needed to seek "Educational Sovereignty" in the same manner that tribal peoples seek "Political Sovereignty."
