# Meeting Minutes: December 3, 2021

# Report: John Crawford, Executive Vice President

- --Student and staff elections are proceeding. Staff voting closes tonight. For the student elections we did have multiple students nominated for President, Vice President, Treasurer and Secretary. Used the same process as before. This time using computers and going according to the by-laws. Student voting opens tomorrow. Possibly extend this into next Monday or Tuesday.
- --Two (2) vacancies for At-large Regents for District 3 & 4.
- --Set up interviews for the Elder Regent.
- --There are no plans for Founders' Day this year due to COVID. Recommended to acknowledge Founders' Day by showing clips from previous Founders' Day Celebration and post on Channel 93 and SGU Website.
- --Planning for a Budget Retreat. Need to plan for the remaining COVID funds. Department of Education funds have to be spent within a timeline this year. Remaining, unspent funds can be spent 4 years into the future. Must submit a four-year plan. Will use unspent funding for renovation of existing buildings and focus on the needs of students. We have so far paid student tuition/fees. Right now, the TIPI building is in bad shape.
- --Comment: It is the Board's responsibility to approve the budgets. It is not right to talk about these things after the fact.
- --Discussion on premium/hazard payments. The Board has a fiduciary responsibility here. Requested a listing of individuals who received these payments and what policy was used to determine eligibility.
- --Dr. Crawford assured the Board that a firm budget will be developed by September and to keep the Board informed.
- --Discussion on IOT and Nursing needs. Technology Building is in need of renovation. Ask the U.S. representatives to research funding availability for tribal colleges.
- -- Need to update our strategic plan.
- --Mr. Lunderman talked about federal dollars dependency and expanding our vision.
- --Request for review of job descriptions for the Vice President(s) and the Executive Vice President.

--Need to revise the Grievance Policy so it is fair and equitable to all employees. Do not feel the present policy is fair to the employees. Possibly a 3<sup>rd</sup> party arbitrator (someone outside of the institution). Someone who will be neutral. Grievance Committee should be set-up either outside or inside the institution. Mr. Crawford will work on a Grievance Policy and bring it to the next meeting.
